ADMISSION GUIDELINES

- The candidate is advised to check the eligibility requirements of the programme for admission. The onus of checking appropriate eligibility lies with the candidate.
- There is no upper age limit for admission in any programme.
- Candidate must bring the copy of the application form filled online.
- Seats reserved for SC/ST/OBC category will be offered to the SC/ST/OBC candidates of Madhya Pradesh domicile only. SC/ ST/ OBC candidates from other states will be treated under unreserved category. SC/ ST/ OBC candidates have to produce category certificate and valid M.P. domicile certificate issued by appropriate authorities at the time of counseling.
- Candidate is required to report in person for counseling on given date and time. Non- appearance in counseling, for whatsoever reason, will automatically disqualify the candidature for the admission. The admissions will be finalized at the time of counseling.
- The information given in the online application form will be verified with the original documents at the time of counseling / admission by the University. If it is found that an applicant has provided incorrect or false information or withheld some relevant information at the time of filling up the online application form, the applicant shall be debarred from admission or the admission can be cancelled at any time during the course of studies without giving any prior notice.
- In case any University / Institute do not show percentage of marks in the mark sheet, a certificate from the competent authority of the University / Institute must be produced stating equivalent percentage of marks as well.
- If reserved seats under SC/ST/OBC category remain vacant in any programme on the day of counseling, vacant seats will be converted to unreserved category. SC/ST seats, will mutually be interchanged if candidates in particular category, are not available.
- The candidate has to bring a demand draft of Rs. 10,000/- drawn in favor of **Registrar, Devi Ahilya Vishwavidyalaya, Indore**, payable at Indore at the time of counseling and it is required to deposit the demand draft for confirmation of the seat.
- Limited hostel accommodation is available within the campus of the university having four boys hostels and five girls hostels. For hostel accommodation admitted candidates are required to contact Chief Warden, Hostels, DAVV, Indore. Students staying in hostel are not allowed to work outside in part/full time. - The decision of the University Authorities shall be final and binding in the matters relating to admission. The rules may be modified without any prior notice and any modification so made shall be binding.
- All admitted students, who are not enrolled with the University, would be required to enroll themselves as per University rules.
- Any legal dispute regarding admission is subject to Indore jurisdiction.

4. Mark sheet and certificate of 10th, 12th, bachelor degree-Original+1 photocopy of each (self-attested).

5. Migration Certificate-Original +1 Photocopy (Self Attested), if available else need to submit by **August 08, 2019**.
6. Caste Certificate for SC/ST/ OBC candidates-Original for verification + 1 Photocopy (Self Attested).
7. M.P. Domicile Certificate for SC/ST/ OBC candidates-Original for verification + 1 Photocopy (Self Attested).
8. Affidavit for gap in studies (if applicable)-Original + 1 Photocopy (Self Attested), if available else need to submit till **August08, 2019**.
9. Candidates who will be admitted on undertaking will have to produce final result (in case of result not declared at the time of counseling) by **August 08, 2019** else admission is liable for cancellation.
