## L Bidders Qualification Criteria (for interactive panels)

Only OEM or OEM authorized vendors are allowed to participate in this bid. In case of OEM authorized vendors, OEM authorization letter for this bid must be submitted by the vendor, failing this will result in bid rejection. The letter must also mention that all support and services will be ensured by OEM for successful and effective execution of software and hardware operations for at least 03 years from the placement of the purchase order.

- 2) Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking in to this effect with the bid.
- 3) Turnover Criteria:(i) Average annual financial turnover of the OEM of the offered product during the last three years, should be Rs. 35 Crore. (ii) The minimum average annual financial turnover of the bidder of IT equipments during the last three years should be as Rs. 2.5 Crore. Submit financial details which clearly mentions the turnover of last five years. Necessary documentary proof should be uploaded.
- 4) The bidder should have minimum of 5 years of experience of sale/supply of Interactive panels and/or equipment of similar type and size. - 2) All the panels and accessories will be accepted after physical verification of the complete inventory and all features as specified in the bid will be tested to full satisfaction for acceptance.
- 3) The unique support service tag numbers associated with the interactive panels and accessories will be tested and verified by DAVV for escalation of support calls as per the call escalation matrix.
- 4) The bidder must demonstrate the facility to perform online checking and downloading of updates of associated software, device drivers, and firmware from OEMs website with the serial no/service tag/device id of the offered product.
