01. The candidates provisionally selected in RAC for Ph. D. programme are required to apply for the Ph. D. registration on prescribed proforma downloadable from the university website. The duly filled registration form along with the necessary documents and certificates shall be forwarded by the research centre after verifying the payments of the fees as notified by the university. The mentoned fees shall be paid through <https://davv.mponline.gov.in>
02. A copy of the receipt of fee should be enclosed with the registration form .
03. Duly forwarded Ph. D. registration form should be submitted to the University and a photocopy of the same form and documents should be submitted to the research Centre. One set of photocopies of registration form and other documents can be kept by the student for his/her record.

04. A tentative topic of proposed work should be mentioned in the Registration form. Final title of the Research work shall be decided at the time of submission of research proposal after completing Ph. D. Coursework and then after by RAC .
05. The course work shall be conducted in Physical Education DAVV indore time table will be notified separately.
06. All the candidate advised to refer Ordinance 11 as notified on 09/01/2024 for all the provisions related to Ph. D. course work and Ph. D.
07. The candidate has to obtain a minimum of 55% of marks or its equivalent grade points in aggregate in the course work in order to be eligible to continue in the Ph. D. programme.
08. After successful completion of the Ph. D. course work the students shall submit the copy of the certificate of the course work and synopsis of the proposed research work duly forwarded by research centre in the prescribed profoma (Appendix –III) of Ordinance 11 to the University within two months from the date of declaration of result of the Ph. D. course work for registration.
09. The candidate shall make an oral presentation of his/her proposed research work before RAC for registration in Ph. D. the RAC Shall recommend the topic of research and the date of registration of the candidate for the Ph. D. degree . On approval by the RAC, the candidate shall be registered and enrolled as a Ph. D. student from the date on which candidate deposited the registration fee or as decided by RAC whichever is letter .

D. course work classes in 24<sup>th</sup> February 2025 the detailed time table will be available on notice board of School of Physical Education and website. They must deposit the duly filled registration form along with the fees receipt to academic section DAVV RNT Marg indore duly forwarded by research Centre.

13. If the candidate is in employment , a no objection certificate form the employer should be submitted.

14. Submit migration Certificate, if qualifying examination passed by university other than Devi Ahilya Vishwavidyalaya Indore .
