IMPORTANT INSTRUCTIONS

1. Candidates provisionally selected for the Ph.D. program must apply for Ph.D. registra on using the prescribed form available on the University website. The completed registration form, along with the necessary documents and certificates, should be subm ed through the respective research center after verification of the prescribed fee payment as per the University's notification. The applicable fees must be paid via MP Online.
2. As per Ordinance 11 (notified on 09/01/2024), candidates are required to deposit the applicable fees, including those for coursework, through MP Online by April 15, 2025. To process the payment, students must use their DET Applica on Number to retrieve the required data on MP Online.
3. In case of any technical problem in payment of fees student is advised to contact School of Compara ve Language and Culture, DAVV, Indore.
4. A copy of the fee payment receipt must be enclosed with the registra on form.

5. The duly verified Ph.D. registration form should be submitted to the University. Additionally, a photocopy of the form and supporting documents should be submitted to the respective Research Centre and the School of Comparative Language and Culture, DAVV. Students are advised to retain one set of photocopies for their records.
6. The tentative research topic must be mentioned in the registration form. The final research title will be determined at the time of research proposal submission, following the completion of Ph.D. coursework and subsequent approval by the Research Advisory Committee (RAC).
7. Ph.D. coursework will be conducted at the School of Comparative Language and Culture, DAVV, Indore. The detailed timetable will be announced separately.
8. Candidates are advised to thoroughly review Ordinance 11 (notified on 09/01/2024) for detailed guidelines regarding Ph.D. coursework and registration procedures.
9. Upon successful completion of the Ph.D. coursework, students must submit a copy of the coursework completion certificate and the research synopsis, duly approved by the research center, in the prescribed Appendix-III format of Ordinance 11. This submission should be made to the University within two months from the declaration of the coursework results.
10. Candidates must present their proposed research work orally before the RAC for registration approval. The RAC will recommend the research topic and determine the candidate's registration date for the Ph.D. program. Upon RAC approval, the candidate will be officially registered and enrolled as a Ph.D. student, effective from either the date of fee payment or as determined by the RAC, whichever is later.
11. Eligibility Certificates will be issued by the Academic Section, DAVV, RNT Marg. The following candidates must obtain an eligibility certificate
 - (A) Those who have completed their Master's degree from an institution other than DAVV or any State University of Madhya Pradesh.
 - (B) Candidates pursuing a Ph.D. in an interdisciplinary subject different from their Master's degree discipline.
12. Candidates without a DAVV Enrolment Number must apply for enrolment through MP Online.
13. Candidates who are currently employed must submit a No Objection Certificate (NOC) from their employer.
14. Candidates who have completed their qualifying examination from a university other than Devi Ahilya Vishwavidyalaya, Indore, must submit a Migration Certificate.

15. For further details, candidates are encouraged to refer to Ordinance 11 and the official university website.

16. Candidates are not permitted to pursue any other degree concurrently while enrolled in the Ph.D. program. An undertaking confirming compliance with this requirement must be submitted in the prescribed format.
