
A meeting of the Committee was held on April 09, 2018.


The Committee examined the decision of Hon. High Court in the matter of Writ petition no. 188/2017(O).


After discussion, the Committee members were of the view that University may prepare a Regulation in context of UGC Regulation, 2010 where constitution of the Selection Committee has been defined.


The draft of the Regulation is attached with these minutes.

Regulation for Selection of Teachers and Principal in unaided minority colleges affiliated to Devi Ahilya Vishwavidyalaya, Indore

UGC in its Regulation 2010 has explited details about Selection of Assistant/ Associate Professors in private colleges/ unaided minority college. Considering guidelines of UGC and in context of decision given by the Hon. High Court, Indore bench in the matter of Writ petition No. 188/2017(O), this Regulation will be effective from the date of its approval by the Competent body/authority:

Assistant/Associate Professor in unaided minority Colleges:

- (a) The Selection Committee for the post of Assistant/ Associate Professor in unaided minority colleges shall have the following composition:
1. Chairperson of the Governing Body of the college or his/her nominee from among the members of the Governing body to be the Chairperson of the Selection Committee.
 2. The Principal of the College.
 3. Head of the Department of the concerned subject in the College.
 4. Two nominees of the Chairperson of the minority College from out of the panel of five names, preferably from minority communities, recommended by the Vice-Chancellor of the affiliating university from the list of experts suggested by the relevant statutory body of the College, of whom one should be a subject expert.
 5. Two subject-experts not connected with the university to be nominated by the Chairperson of the Governing Body of the minority college out of the panel of five names, preferably from minority communities, recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body of the College.
 6. An academician representing SC/ST/OBC/Minority/Women/Differently-abled categories, if any of candidates representing these categories is the applicant, to be nominated by the Vice Chancellor or Acting Vice Chancellor, if any of the above members of the selection committee do not belong to that category.
- (b) To constitute the quorum for the meeting, five of which at least two must be from out of the three subject-experts shall be present.
