Other Important Points

- Seats reserved for SC/ST/OBC/PWD and EWS categories will be offered to the SC/ST/OBC/PWD and EWS candidates of Madhya Pradesh domicile only. SC/ST/OBC/PWD and EWS candidates from other states will be treated under unreserved category. Change of category shall not be accepted at any stage. To avail benefit of reservation a certificate from a Competent Authority should be produced.
- 2. Candidates who are admitted provisionally on undertaking regarding result, will have to produce final result (in case result is not declared at the time of counseling/ ATKT / Compartment) by 31st October 2022 or any other date decided by the University, else admission will automatically be cancelled.
- 3. Any matter, not covered by provisions mentioned in this guideline shall be referred to the Organizing Committee / Admission Cell which will work within the ambit of Act, Statutes and Ordinances of Devi Ahilya Vishwavidyalaya, Indore and its decision shall be final.
- 4. The legal disputes regarding counseling, if any, shall be settled within the jurisdiction of Indore.

5. In case it comes to the notice that an applicant has secured admission based on forged certificate/s or by furnishing wrong information, willingly concealing adverse facts or due to administrative or official negligence, his/her admission will be cancelled immediately without giving any notice.

Counseling process

- 1. Only registered candidates can appear in the counseling.
- 2. Counseling will be conducted on the basis of broad guidelines of Directorate of Technical Education (DTE), M.P. and its Lookup order for seat allotment.

Counseling for NRI / NRI sponsored:

1. Counseling for NRI / NRI sponsored seats will be done on 16.08.2023 at 2.30PM at EMRC, Takshashila Campus, Khandwa Road, Indore.

Legal Jurisdiction

1. All disputes pertaining to the counseling process of CUET (PG) – 2023 shall fall within the jurisdiction of Indore only.

Fee:

1. The candidate will be provisionally admitted in the program subject to online submission of first semester fee. Candidate has to submit required fee within the time period given in the counseling schedule / allotment letter, failing which, his / her admission will be cancelled.

Cancellation of Admission and Refund of Fee

- 1. If any candidate wants to cancel the admission, he / she should be apply in prescribed proforma. Proforma will be available on University web site www.dauniv.ac.in.
- 2. In case, if any candidate leaves the program, the fees will be refunded as per the guidelines of UGC, New Delhi for the year 2023. If a candidate leaves any program after the said date, only caution money will be refunded (If the candidate has deposited full fees). Please note that request for refund of fee will be processed by the University office/ concerned department and only after approval of the Govt. audit, refund will be made.
- 3. In cases, where candidates have fetched an undertaking to the effect, that, their admission may be deemed cancelled in case they fail to produce their result of qualifying examination with

required eligibility percentage by 30th September, 2023 or as decided by University, there will be no refund of fee deposited.

4. If a provisionally admitted student is declared Fail in qualifying exam then he / she should inform to concerned School / Institute / Department on or before 30th September, 2023 and his/her deposited fee will be refunded after deducting Rs. 1000/-.
