The RAC (Interview) for <u>Ph.D. in Economics</u> is scheduled on 30th September 2025. at <u>10:30 AM</u> at School of Economics, D.A.V.V. Takshashila campus, Khandwa Road, Indore. Candidates are advised to carefully review Ordinance 11 and the guidelines for RAC (Interview). They must bring all original documents, along with one set of photocopies, the Candidate Information Form, and the Consent Form (if available).

As specified in the Consent Form, candidates must attach or bring all relevant annexures related to their supervisor/co-supervisor. However, submitting the Consent Form is not mandatory, as the RAC will allocate a supervisor if the candidate does not have a consent letter. Further Submission of consent from not necessarily ensures allocation of same Supervisor/Co-Supervisor.

The evaluation in interview will be based on the following criteria (25 Marks each)

- (i) Research plan
- (ii) Research potential/aptitude
- (iii) Communication skills
- (iv) Subject knowledge in the respective area of research.

Hence, the candidates are required to come with a synopsis for RAC Interview. Participation in the RAC interview does not guarantee admission to the Ph.D. Course work.

Guidelines for Students Regarding RAC (Interview)

- 1. On the day of scheduled RAC (Interview), candidate shall fill up student information form, sign attendance sheet.
- 2. No objection letter (Consent Form) duly signed by supervisor and Head research center must be attached with Student Information Form along with other relevant documents such as Caste/domicile/income/PH/EWS (wherever applicable) certificates.
- 3. Reservation of seats under different category shall be as per Govt of MP rules.
- 4. Candidates are advised to read page no. 4 of Ordinance 11 available at website.
- 5. Candidates are required to discuss their research interest/area through a presentation before RAC. The committee shall evaluate the research potential of the candidate, ingenuity of research and suitability of research center through direct interaction with the candidates. Therefore, candidate should bring a short write up of **Research plan (up to 1000 words, in 5 copies)** illustrating broad area of research work to be undertaken, importance and applications. Candidates might also be asked to make a power point presentation of Research plan. Hence, they are advised to bring a power point presentation (3-4 slides).
- 6. The evaluation in interview will be based on the following criteria (25 Marks each)
 - (i) Research plan
 - (ii) Research potential/aptitude
 - (iii) Communication skills
 - (iv) Subject knowledge in the respective area of research.
- 7. Please note that even if the candidate does not have a consent letter, (s) he must appear for the RAC interview, as the RAC may allot a Supervisor/ Co-Supervisor to the candidate as per its own discretion.
- 8. It may also be noted that merely having a consent letter shall not guarantee admission.
- 9. All the candidates (JRF) who were exempted from written test will have to show their original proof of exemption.
- 10. The list of Ph.D. Supervisors with their respective vacant seats is available on University website, www.dauniv.ac.in.
