4. General Rules of Admission for NON-CUET Programmes

- **4.1**. The candidate is advised to apply for admission only if he/ she fulfills the eligibility requirements. The onus of checking appropriate eligibility lies with the candidate only.
- **4.2.** Applicants are required to apply on-line through https://davv.mponline.gov.in portal.
- **4.3.** The admission process in different programmes will be carried out by the respective departments/ schools/ institutes/ centers, where the programmes are offered.

- **4.5.** If an applicant wishes to be considered for more than one programme, he/ she must apply in separate application form for each programme.
- **4.6.** The name of the candidate must be the same as given in the mark sheet of the qualifying examination of the Board/ University. Competent authorities should certify the discrepancies in the names of various mark sheets, if any.

- **4.7**. Candidate is advised to mark/write correctly his/ her category and is required to **enclose appropriate certificate to claim the benefit**. Change of category shall not be accepted thereafter.
- **4.8.** The candidates who **fail to indicate the appropriate** reservation category in the respective column of the application form will not have any claim for the reservation later on.
- **4.9.** The admission to various programmes will be strictly as per the **Government of Madhya Pradesh** reservation policy.
- **4.10**. The information provided by the applicant in the application form will be **verified at the time of counseling/ admission** from the original documents by the authorities of University. If the applicant is found to have given incorrect/ false information at any point of time or to have omitted any relevant information at the time of completion of the application form, the applicant shall be disqualified from admission. Applicant's admission shall be treated as cancelled without giving any prior notice.
- **4.11**. In case if any Board of examination/ University/ Institute does not show percentage of marks in the mark sheet, a certificate from the competent authority of the Board/ University/ Institute must be produced **stating equivalent percentage of marks** as well as conversion formula used, along with the mark sheet at the time of admission.
- **4.12**. The decision of the university authority in the matter of admission shall be final and binding. As per the directives of statutory bodies/ **Government of Madhya Pradesh** if any rules are modified and the same shall be binding on the applicants' admission.
- 4.13. The University have already adopted the changes and reforms proposed in New Education Policy 2020.
- **4.14.** The **University reserves the right to rename any programme degree**, make variations in the contents and methods of delivery of courses and other services, to discontinue course and other service and to merge or combine courses, if such action is reasonably considered to be necessary.

- **4.15.** Any **legal dispute regarding** Admission-2025 will be subject to Indore jurisdiction.
- **4.16.** No written communication will be provided. Applicants are advised to see the university website.
- **4.17**. University reserves the right to modify/ alter any information provided in advertisement and Admission information brochure at any stage.

5. Eligibility for Admission

Eligibility, Seats, Admission Mode, Date

- 5.1. Number of seats for admission to programmes being offered by the University, Eligibility, Admission Mode are mentioned in the table given below. Fee structure is also given in the concerned table. A relaxation of 5% in the eligibility criteria shall be admissible to the bonafide Scheduled Caste (SC) and Scheduled Tribe (ST) applicants. A relaxation of 5% in eligibility will also be applicable to Persons with Disability (*Divyang*) as defined by Government of Madhya Pradesh.
- 5.2. The admission will purely be given on the basis of merit which will be prepared by the concerning department based on its own set criteria (Counselling/ written exam), it may be based on qualifying examination or interview or any other mode/s or combinations of modes. (Except M.P.Ed., B. Ed., & M. Ed).
- **5.3.** The eligibility of merit will be considered on the basis of aggregate of marks/ grades up to their previous years, whereas for the students from semester system, the aggregate of marks/ grades up to penultimate Semester.
- 5.4. However, if they have appeared in their final semester/ year examination and the results have been declared by 30th May 2025 i.e.,

- the last date for submission of the application, their final semester/ year result will be considered for the merit purpose. Such candidates will have to submit the mark sheet in the concerned department latest by **14**th **August 2025**.
- 5.5. The candidates awaiting their results of qualifying examination will have to submit the final mark sheet of qualifying examination by 14th August 2025 or by the date as notified by Government of Madhya Pradesh.
- 5.6. Candidates who have passed their qualifying examination from Universities other than Devi Ahilya Vishwavidyalaya are required to submit **Eligibility Certificate issued by the Devi Ahilya Vishwavidyalaya**, Indore after the admission.
- **5.7.** Admission will be given **only in first semester/ first year** of the course except in case of lateral entry in B.Pharm.

6. Age Limit

As per the directives of Government of Madhya Pradesh, there is no upper age limit for admission to the various programmes. Guidelines and rules for admission framed by **Government of Madhya Pradesh** regarding age limit will be opted in toto.

7. Non-eligibility for Admission

7.1. An applicant convicted by the court of law in India or outside or one against whom cases are being tried in the court/s or challan has been presented or has verifiable allegations against him/ her concerning misbehavior/ beating of students/ officers/ employees or a person against whom disciplinary action has been taken by Devi Ahilya Vishwavidyalaya or any other University shall not be eligible for admission.

7.2. A **full-time government/non-government employee cannot** take admission in courses conducted during his/her working hours. However, they can take admission in courses conducted during their regular non working hours. For the same, they will have to produce a No Objection Certificate (NOC) from their employer.

8. Reservation Policy and Conversion of Seats

- **8.1**. Reservation will be as per the directives of Government of Madhya Pradesh from time to time.
- **8.2.** The reservation benefit will only be available to the residents of Madhya Pradesh as per the rules laid down by the state government.
- **8.3.** A horizontal reservation of 30 percent of the total seats will be for female applicants.
- **8.4.** If less than half seat falls under reservation, then the seat will not be available: in case the proportion of seat is between half and one, it will be treated as one.
- **8.5.** Conversion of vacant seats among reserved categories (SC/ST/OBC) will be done as per M.P. Government directives.
- **8.6.** To avail benefit of reservation, a certificate from a Competent Authority should be produced.
- **8.7.** The candidate (applicant) must indicate explicitly the category for which he/ she wishes to avail the advantage of reservation for admission. This option will, in no case, be allowed to be changed.
- **8.8** If reserved seats remain vacant, the seats will be converted to unreserved category.
- **8.9.** The candidate admitted under NRI category will not be transferred to any other category.

8.10. DAVV employee ward quota: Admission for wards of the University employees will be made as per the notification issued by the University. These admissions will be "over and above" with respect to total number of seats available in the concerned programme.

(DAVV employee ward here would mean the Teacher/ Officer/ Employee's husband, wife, son and daughter. In this respect, at the time of admission, a certificate from the University's Registrar, Devi Ahilya Vishwavidyalaya, Indore/ Competent Authority is required). Note: These seats are interchangeable, and can be converted to other category (Teacher/ Officer to Employee vice - versa) if they remain vacant.

9. Other Important Points

- **9.1.** Any situation, not covered by provisions mentioned in these guidelines shall be referred to the Admission Committee which will work within the ambit of Act, Statutes and Ordinances of Devi Ahilya University, Indore and its decision shall be final.
- **9.2.** Legal disputes, if any, shall be settled within the legal jurisdiction of Indore.
- **9.3.** Ragging, teasing, torturing or making nuisance in any way inside or outside the campus has been declared as a serious offence and strict action shall be taken against those who will be found involved in such activities.
- **9.4.** In case if it comes to the notice that an applicant was able to secure admission based on forged certificate/s or by furnishing wrong information, willingly concealing facts or due to administrative or official negligence, his/ her admission will be cancelled immediately.
- **9.5.** If a student, after taking regular admission, fails to maintain required percentage of the attendance for each subject in the course, he/ she will not be eligible to appear in tests/ final exam.

- **9.6.** Devi Ahilya Vishwavidyalaya, Indore, will use all reasonable endeavors to deliver programs, duration and other services in accordance with the descriptions set out in this guidelines. The University reserves the right to rename any programme degree, make variations in the contents and methods of delivery of programs and other services, to discontinue program and other service and to merge or combine programs, if such action is reasonably considered to be necessary.
- **9.7.** All admitted students, who are not enrolled with the University, would be required to enroll themselves as per University rules.

10. Hostel Accommodation

There are limited number of separate hostels for boys and girls. For hostel accommodation, provisionally admitted candidates are required to contact the Office of the Chief Warden, DAVV, Indore.

11. Refund of Fee

- 11.1. If a candidate leaves the programme before 30th September 2025, the deposited fee will be refunded after deduction of Rs.1000/-.
- **11.2.** Only caution money will be refunded if a candidate leaves any course after the said date. Please note that request for refund of fee will be processed in the University office and will be done only after the approval of Govt. audit.
- 11.3. In cases where a provisionally admitted student is declared fail, or candidates who have fetched an undertaking to the effect that their admission may be deemed cancelled in-case they fail to produce their result of qualifying examination with required eligibility percentages by 30th September 2025 or by the date as notified by Government of Madhya Pradesh, there will be no refund of fee deposited except caution money.

12. Procedure of admission for M.Tech. Programmes.

Admission in M.Tech. (Full-Time) Programmes

Preference will be given to GATE qualified candidates. However, in case of non-availability of GATE qualified candidates, admission will be offered to NON- GATE candidates

For GATE qualified candidates: Admission shall be made on a merit list developed on the basis of GATE score for each Programmes, separately. The candidates are required to submit result of final semester on or before the date notified by the School/Institute, failing which admission shall be treated as cancelled.

For NON-GATE candidates: Admission shall be made on the basis of a merit list developed considering average marks/SGPA upto seventh semester (B.E./ B.Tech.) / Fifth semester (M.C.A.) /Third semester (M.Sc.). However, such candidates have to submit result of final semester on or before the date notified by the School/Institute, failing which admission shall be treated as cancelled.

Admission in M.Tech. (Part-Time) / (Executive) Programmes/Sponsored candidates:

The admissions will be made as per the merit developed on the basis of % of marks obtained in the following categories:

The admission will be confirmed after verification of the documents. After the confirmation of admission, candidate has to deposit fee within the notified period. During the process of document verification, if it is found that an applicant has provided incorrect or false information or withheld some relevant information at the time of filling up the online application form, the applicant shall be debarred from admission or the admission can be cancelled at any time during the course of studies without giving any prior notice.

If a candidate fails to deposit fee within the notified period, his/her admission will be treated as cancelled and the seat will be offered to other candidate as per the order of merit and choice of the candidate.

AICTE Scholarships to GATE Qualified Candidates:

There are 13 stipend seats approved by AICTE @ Rs. 12400 per month under Direct Benefit Transfer scheme. The above stipend is available for following M.Tech. programs.
