Guidelines for writing Ph.D. thesis on CD

1. All the files in CD shall be in PDF/A format, with OCR enabled. (Two CDs are required)
2. There shall be two folders in both the CD - the first folder named as **“Thesis for Plagiarism Check”** **Containing** a single file in the folder, the whole thesis shall be saved as a single PDF/A document with following file name: **REG. Year_REG. No_Name of Candidate.pdf** (For instance - **2016_4675_Rajesh Singh. Pdf**)
3. All Thesis Written in non-English Languages (**Hindi, Urdu etc.**) Needs to be Typed in
4. **Unicode Font. (For Hindi Mangal etc.)** For it to be checked in **DRILLBIT**
5. The second folder shall be named **“Thesis for Shodhganga”** and inside this folder, different section of the thesis shall be saved as separate PDF/A files **Strictly** as follows.

01_Title_Page in English (Hinglish) & Hindi (Unicode Mangal.)

02_prelim pages. (Title Page + declaration + dedication + certificate + acknowledgment + list of Table + Graphs, etc. files together as a single file)

03_Contents

04_ Abstract (100-300 Words)

05_Chapter 1

06_Chapter 2

07_Chapter 3

08_Chapter 4

09_Chapter 5 (more such files can be added if needed)

10_Annexures. (Also combine the bibliography + references+questionnaire+maps+publications, etc. files together as a single file)

11_80_Recommendations (should contain title page and chapter which Contains Recommendation/Conclusion/Summary/Future findings/without any images).

12. Letters of Registration
