ADMISSION RULES AND INSTRUCTIONS

1. The candidate is advised to apply for admission only if he/she fulfils the eligibility requirements.
2. **The onus of checking appropriate eligibility lies with the candidate.** Candidate must read and understand the details given in the guidelines available on the web site <http://www.dauniv.ac.in> carefully before filling the application form.
3. Check the form thoroughly before online payment, unpaid form will not be accepted in any case.
4. The Online application fee (non-refundable) is Rs.750/- (Rs. 400/- for SC/ST candidates of M.P. domicile). In addition to the application fee a portal fee, Rs.50/- will also be applicable. Candidate can pay fee online through MP-Online authorized KIOSK in MP or through any ATM cum Debit Card/ Credit Card or Net Banking from anywhere. If your amount is deducted and receipt is not generated, pay the fee again, as previous amount will be reverted automatically into your card or bank account. 5. Eligibility for M.Sc. Data Science for Logistics. Admission:

B.Sc. with Mathematics / Statistics / Computer Science as one of the main subject *OR* B.E./ B.Tech. in any discipline with at least 50% marks in aggregate or an equivalent grade for General / OBC candidates, and 45% marks in aggregate or an equivalent grade for SC/ST and Differently Abled (DA) category candidates from a recognized University/Institute.
6. Number of seats: **30**
7. The last date of application form is, **2022**.
8. Procedure of admission: Admission shall be made on a merit list developed on the basis of qualifying examination Percentage/grade point. The merit list and counselling schedule will be uploaded only on www.dauniv.ac.in
9. The tentative date of offline counselling is 27/12 /2022. No written communication will be provided regarding counselling; Applicants are advised to keep-on visiting www.dauniv.ac.in for counselling schedule and venue.
10. Admission shall be offered after the document verification on the day of counselling. The information provided by the applicant in the application form will be verified at the time of **counselling** from the original documents by the authorities of University. If the applicant is found to have given incorrect/ false information at any point of time or to have omitted any relevant information at the time of completion of the application form, the applicant shall be disqualified from admission. Applicant's admission shall be treated as cancelled without giving any prior notice.
10. Admission shall be offered after the document verification on the day of counselling. The information provided by the applicant in the application form will be verified at the time of **counselling** from the original documents by the authorities of University. If the applicant is found to have given incorrect/ false information at any point of time or to have omitted any relevant information at the time of completion of the application form, the applicant shall be disqualified from admission. Applicant's admission shall be treated as cancelled without giving any prior notice.
11. The name of the applicant must be the same as given in the mark sheet of the qualifying examination of the Board. Competent authorities should certify the discrepancies in the names of mark/grade sheets, if any.

12. Applicant is advised to mark/write correctly his/her category to claim the benefit. Change of category shall not be accepted thereafter.
13. The candidates who fail to indicate the appropriate reservation category in the respective column of the application form will not have any claim for the reservation later on.
14. In case any Board / Institute do not show percentage of marks in the mark/grade sheet, a certificate from the competent authority of the Board / Institute must be produced stating equivalent percentage of marks as well.
15. The decision of the university authority in the matter of admission shall be final and binding. As per the directives of statutory bodies/ Government of Madhya Pradesh if any rules are modified and the same shall be binding on the applicants' admission.
16. The reservation rules of government of Madhya Pradesh will be applicable for the admission for the candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Classes (Non-creamy Layer), and Horizontal Reservation for female candidates.
 - 16.1 Seats reserved for SC/ST/OBC (Non-creamy layer) category will be offered to the SC/ST/OBC (Non-creamy layer) candidates of Madhya Pradesh domicile only. SC/ST/ OBC (Non-creamy layer) candidates from other states and the candidates from other reserved categories from any state will be treated under unreserved category.
 - 16.2 SC/ST/OBC (Non-creamy layer) candidates have to produce valid category certificate and M.P. domicile certificate issued by competent authorities at the time of document verification.
 - 16.3 Reservation for Economical weaker section (EWS) candidates of Madhya Pradesh is as per rule of government of Madhya Pradesh.
17. Limited hostel accommodation is available within the campus of the university.
18. Any legal dispute regarding admission is subject to Indore jurisdiction.
