**Regulation for Selection of Teachers and Principal in minority colleges
affiliated to Devi Ahilya Vishwavidyalaya, Indore**

UGC in its Regulation 2018 has given details about Selection of Assistant Professors/ Associate Professors/ Professors in minority colleges. Considering guidelines of UGC & in context of decision given by the Hon. High Court, Indore bench in the matter of Writ petition No. 188/2017(O), this Regulation will be effective from the date of its approval by the Competent body/authority:

Assistant Professor/Associate Professor/Professor in minority Colleges:

(a) The Selection Committee for the post of Assistant Professor/Associate Professor/Professor in minority Colleges shall have the following composition:

1. Chairperson of the Governing Body of the college or his/her nominee from amongst the members of the Governing body to be the Chairperson of the Selection Committee.
2. The Principal of the College.
3. Head of the Department/Teacher Incharge (Not below the rank of the Post for which the selection is to be made) of the concerned subject in the College.
4. Two nominees (one should be a subject expert, not below the rank of the Post for which the selection is to be made) of the Chairperson of the minority college from out of the panel of five names, preferably from the minority communities, recommended by the Vice Chancellor of the affiliating University, from the list of experts suggested by the relevant statutory body of the college.
5. Two subject-experts (not below the rank of the Post for which the selection is to be made) not connected with the University to be nominated by the Chairperson of the governing body of the minority college out of a panel of five names, preferably from minority communities, recommended by the Vice Chancellor from the list of subject experts approved by the relevant statutory body of the College.
6. An academican (not below the rank of the Post for which the selection is to be made) representing SC/ST/OBC/Minority/Women/Differently-abled categories, if any of candidates representing these categories is the applicant, to be nominated by the Vice Chancellor, if any of the above members of the selection committee does not belong to that category.

(b) Five members, including two outside subject experts shall constitute the quorum.

College Principal

- (a) The Selection Committee for the post of College Principal shall have the following composition:
1. Chairperson of the Governing Body as Chairperson.
 2. Two members of the Governing Body of the college to be nominated by the Chairperson of whom one shall be an expert in academic administration.
 3. One nominee of the Chairperson of the College from out of a panel of five names, preferably from minority communities, recommended by the Vice-Chancellor of the University. This nominee shall be Higher Education expert/ subject expert.
 4. Three Higher Education experts consisting of the Principal of a college, a Professor and an accomplished educationist not below the rank of a Professor (to be nominated by the Governing Body of the college out of a panel of six experts approved by the relevant statutory body of the University).
 5. An academican representing SC/ST/OBC/Minority/Women/Differently-abled categories, if any of candidates representing these categories is the applicant, to be nominated by the Vice Chancellor, if any of the above members of the selection committee does not belong to that category.
- (b) At least five members, including two experts, shall constitute the quorum.
- (c) All the selection procedures of the selection committee shall be completed on the day of the selection committee meeting itself, wherein, minutes are recorded along with the scoring proforma and recommendation made on the basis of merit with the list of selected and wait listed candidates/Panel of names in order of merit, duly signed by all members of the selection committee.
- (d) The term of appointment of the College Principal shall be five years with eligibility for reappointment for one more term only after a similar Selection Committee process.

For all the posts, eligibility criteria will be as per UGC Regulation 2018 with amendments from time to time. No relaxation in the eligibility criteria will be given by any of the Committee constituted in the process of selection.

The minutes of the Selection Committee in sealed envelope will be opened in the meeting of the Governing body of the College for consideration and approval..

If minutes of the Selection Committee are approved by the Governing body of the College, the same along with all the documents and minutes of the Governing body will be sent to the University for final approval.
