Note:

1. The candidates provisionally selected in RAC for Ph.D. programme are required to apply for the Ph.D. registration on prescribed proforma downloadable from the university website. The duly filled registration form along with the necessary documents and certificates shall be forwarded by the research centre after verifying the payments of the fees as notified by the University. The mentioned fees shall be paid through <https://davv.mponline.gov.in>.
2. A copy of the receipt of fee should be enclosed with the registration form.
3. Duly forwarded Ph.D. registration form from Head, research centre, guide should be submitted to the University and a photocopy of the same form and documents should be submitted to the Research Centre and School of Commerce, DAVV. One set of photocopy of registration form and other documents can be kept by the student for his/her record.
4. A tentative topic of proposed work should be mentioned in the Registration form. Final title of the research work shall be decided at the time of submission of research proposal after completing Ph.D. Coursework and then after by RAC.
5. The course work shall be conducted in School of Commerce, DAVV, Indore . Time Table will be notified separately.
6. All the candidates are advised to refer Ordinance 11 as notified on 09/01/2024 for all the provisions related to Ph.D. course work and Ph.D.
7. The candidate has to obtain a minimum of 55% of marks or its equivalent grade points in aggregate in the course work in order to be eligible to continue in the Ph.D. programme.
8. After successful completion of the Ph.D. course work the students shall submit the copy of the certificate of the course work and synopsis of the proposed research work duly forwarded by research centre in the prescribed proforma (Appendix-III) of Ordinance 11 to the University within two months from the date of declaration of result of the Ph.D. course work for registration.
9. The candidate shall make an oral presentation of his/her proposed research work before RAC for registration in Ph.D. The RAC shall recommend the topic of research and the date of registration of the candidate for the Ph.D. degree. On approval by the RAC, the candidate shall be registered and enrolled as a Ph.D. student from the date on which candidate deposited the registration fee or as decided by RAC whichever is later.
10. The eligibility certificate will be issued by the Academic Section, DAVV, RNT Marg, Indore. The following students will need eligibility certificate:-
 - i. All the students who have done their Master Degree from the University/Institute other than DAVV or any state University of Madhya Pradesh.
 - ii. The students who are interested to do Ph.D. in interdisciplinary area (other than the subject of Master's degree)
11. The students who do not have enrolment number from DAVV, Indore should apply for Enrolment Number through MP online.
12. As per Ordinance 11 as notified on 9/01/2024 the above students have to deposit the fees including course work through MP Online before 1st September, 2025. The tentative date for commencement of Ph.D. course work classes is 2nd Week of September, 2025. The detailed time table will be notified separately. They must deposit the duly filled registration form along with the fees receipt to academic section DAVV, RNT Marg, Indore duly forwarded by research centre.
13. If the candidate is in employment, a no objection certificate from the employer should be submitted.
14. Submit migration certification, if qualifying examination passed by University other than Devi Ahilya Vishwavidyalaya, Indore.
15. No student is allowed to pursue any other degree while pursuing Ph.D. An undertaking to this effect is to be submitted by the student in the attached format.
