(A) Scope of work

Devi Ahilya University is having two campuses namely Takshashila and Nalanda campus, which are 7.0 Km. apart. The University is having a campus wide network which individually interconnect different UTDs at Takshashila campus and various administrative departments at Nalanda campus. The ring road further divides the Takshashila campus in two parts. In one part IET and Pharmacy departments and some hostels are located and all other UTDs are located in second part. The campus wide network is administered from IT Center, which is located in central library building inTakshashila campus. Quotations/Bids are called for the purchase of dead OFC based leased line service to connect Nalanda campus network to IT Center as well as IET-Pharmacy network to IT Center.

(B) Technical Specifications

- (i) IT Center to Nalanda Campus link: Two core Single mode OFC based leased lineservice between IT center and Nalanda campus, RNT, Marg Indore. (Distance around 7 Km.) One core two be terminated on 1st floor (exam section) of main administrative building, and the second core to be terminated on 1st floor at establishment section located in Account Office building.
- (ii) IT Center to IET-Pharmacy Link: Twelve core (12 cores) single mode OFC basedleased line Service between IT Center and B-block at IET (Distance around 2 Km.). Three cores to be terminated in J C Bose Boys hostel and remaining nine (09) cores to be terminated in B-block lab of IET.
- (iii) Network & Service Availability: Average network availability per calendar monthacross the IP network > 99.50%. The service provider must maintain alternate cable route for high availability.
- (iv) Packet Delivery:Backbone Network Packet Delivery >=99%. The packet loss would becalculated by taking an average over a period of 1 month.

(C) Eligibility Criteria

- (i) Company Turnover: Minimum Rupees 25 Lakh per annum from OFC based leased lineservice for last three years.
- (ii) Experience: Minimum three years' experience either as OFC based lease line

- serviceprovider or of maintaining and laying of optical fiber cable in public areas. Attach supporting documents. (envelope A)
- (iii)Local Manpower Availability: The bidder must have local office in Indore for last 3 years and should have at least 5 trained persons working at Indore office. Attach supporting documents (envelope A)
- (iv) Service Provider must be having at least of 50 KM of his own fiber optic network in running condition in public areas. Attach supporting documents (envelope A)

(D) General Terms and Conditions

- 1. The Bidder cannot transfer awarded contract into subcontract.
- 2. The Bidder should submit certified copy of satisfactory performance of leased line service provided at other locations. Giving the details about the location, type of lease service and duration of the service.
- 3. The individual signing the document and other documents on behalf of the bidder should submit proof in support of his /her authority.
- 4. DAVV may modify the Scope of work in the best interest of the University, if the necessity arises. Any change or modification in the scope of work or the content will be notified on University website www.dauniv.ac.in
- 5. The tender submitted should be valid till 180 days from its date of submission.
- 6. The successful bidder shall provide the services as mentioned in the scope of work and carry out its other obligations under the agreement with due diligence, efficiency and economy. It shall apply appropriate advanced technology and safe and effective methods during execution of this contract.
- 7. The track record of the bidder should be clean and should not have any involvement in illegal activities or financial misappropriation /frauds etc.
- 8. Earnest Money Deposit (EMD) Rs.10,500/- in favor of <u>Registrar, Self-Finance, DAVV, Indore (to be submitted in online mode). The printed receipt to be submitted in sealed envelope A. Without EMD, the tender shall be considered as invalid and summarily will be rejected.</u>
- 9. Performance guarantee as 5% of order value at the time of signing service contract will have to be deposited by the shortlisted bidder. Performance guarantee can be submitted as bank guarantee/ F.D.R./banker's cheque /demand draft from a scheduled bank.
- 10. Initially the service contract will be awarded for one year to shortlisted bidder. It may be extended for two more years, subject to giving satisfactory services in previous year.
- **11.** We do not intend to call vendors for financial negotiations. Vendor should, therefore, quote their lowest possible rates.
- 12. Financial bid will be opened only for technically qualified bidders.
- 13. Bids received after due date will be summarily rejected.
- **14.** DAVV reserves the right to reject any or all offers without assigning any reason thereof.
- **15.** All disputes shall be jurisdiction of courts of District Indore only.

13 **Penalty Provisions:**

Failure to maintain above dead line would result in penalty charges at the rate of Rs. 2000/- per day. In any case maximum penalty would not exceed 50% of the order value.

- (iii) In case services are not restored within three days, DAVV shall be free to get the work done through any agency and expenditure incurred on this account due to failure of the service provider to deliver the services shall be deducted from the balance payment or security deposit.
